#### WNML'S "COORS LIGHT MANCAVE MAKEOVER" CONTEST OFFICIAL RULES

The Station will conduct the **WNML's "Coors Light Mancave Makeover"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

# 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

**On-Air:** Listen to the Station weekdays during the Contest Period from 6:00am to 9:00am, 9:00am to 12:00pm, 12:00pm to 3:00pm, and 3:00pm to 7:00pm CT (each a "Contest Round") except on October 12, 2023 when the . Station will play one (1) cue to call sounder during each Contest Round. When the Station plays the "cue-to-call" sounder, , listeners must call the Station at 865-656-9467. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win (each a "Qualifier"). *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast*. Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.

4. **Winner Selection.** On or about 12:00pm ET on October 12, 2023, Station will select one (1) potential winner in a random drawing from among all valid Qualifiers. be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.
